

BRAZIL, PERU, COSTA RICA STUDY ABROAD SPRING 2023



Destinations: Brazil (Rio, Iguazu Falls), Peru (Lima, Machu Picchu), and Costa Rica (San Jose, Tamarindo)

This amazing program will bring students to Latin America, one of the world's most dynamic and important regions. We will learn about business there by visiting companies and talking with managers who run them. In addition, you will visit the wonderful cultural sites of Latin America, such as Brazil's massive Maracana stadium, which hosted the 2014 World Cup and the 2016 Olympic games. We will also visit the amazing Machu Picchu of Peru, Rio De Janeiro's Christ statue (Corcovado), the spectacular Iguazu Falls, and the beautiful Arenal volcano and beaches of Costa Rica.

<u>Business visits</u> (tentative): Google, Ford, Nestle, Telefonica (Brazil), Nike, Deloitte, MorganStanley (Peru), Proctor & Gamble, Amazon, Wal-Mart, Intel (Costa Rica).

<u>Cultural visits</u> (tentative): <u>Brazil</u>: Iguazu Falls, Corcovado (Christ Statue), Maracana soccer stadium, Copacabana Beach; <u>Peru</u>: Machu Picchu, Cusco, Lima Basilica cathedral, Huaca Pucllana (giant adobe pyramid); <u>Costa Rica</u>: Arenal Volcano National Park and hot springs, ancient temple ruins, pristine beaches and rainforest.

DATES

HOUSING

Students will stay in hotels or hostels provided by the program. Housing is included in the program cost.

COURSES

Students will receive 6.0 credit hours (in addition to the 1.0 credit for the prep course) for the following: MSB 430—Introduction to International Business (3.0 credits)

HRM 300—Organizational Behavior (3.0 credits; fulfills a business minor requirement) or

HRM 391—Organizational Effectiveness (3.0 credits; fulfills a business major requirement)

This program will fulfill course and international experience requirements for the Global Business Certificate offered by the Marriott School.

COST

\$9,900-10,500

Includes Latter-day Saint, undergraduate full tuition (increased cost for graduate and non-Latter-day Saint students), all airfare, lodging, group cultural activities, international health insurance, and some meals.

Does not include personal expenses such as non-covered meals, souvenirs, public transportation, museums, and other attractions that are not part of the program.

TRAVEL

Flights which are covered by the program cost will be arranged by the program directors through a BYU Travel agent. Students may not purchase their own flights.

PREPARATION

Accepted students are required to participate in an international, cross-cultural preparation course (IAS 201R, 1.0 credit hour), held on an evening (to be determined) of the second term of winter semester 2023.

Part-time BYU students and non-BYU students will need to pay an additional tuition fee of approximately \$304.

Students must meet all country- and program-specific COVID and health requirements for travel.

FUNDING SOURCES

Regular BYU tuition scholarships, Pell Grants, and Federal Insured Student Loans may be applied to study abroad programs. Students who submit the financial aid section of the ISP application and who have a current FAFSA form on file at the Financial Aid Office (A-41 ASB) will be considered for a study abroad scholarship and may be considered for other scholarships. Academic departments and colleges may assist with scholarships and grants.

Private grants and scholarships outside of BYU may also assist (see kennedy.byu.edu/scholarships).

APPLICATION PROCESS

Complete the online application at kennedy.byu.edu/isp-apply.

The application requires a \$35 fee.

Applicants will be interviewed once the application is complete.

Students will be notified via e-mail of their acceptance into the program.

The first payment is due upon acceptance.

Priority deadline: 15 October 2022 Application deadline: 30 December 2022

Space is limited and will fill fast. Priority will be given to those who apply early.

FACULTY
