The program is designed for you to learn about international real estate investment and the challenges facing global investors. In addition, you will have time to see many world-renowned locations such as the Eiffel Tower, Louvre, Big Ben, Roman Colosseum, Sistine Chapel, and the Swiss Alps just to name a few.

### HOUSING

Students will stay in hotels. All housing arranged by the program.

### COURSES

Prerequisites: FIN 413 — Real Estate Finance and Investment OR MBA 686 — Real Estate Analysis AND/OR Active in BYU Real Estate Association (BREA) with real estate internship

### COST

\$4,400-4,800

Includes housing, breakfasts and some lunch/dinners, group transport on field trips, and international health insurance.

Does not include airfare to/from Europe, some meals, and personal expenses.

### **FUNDING SOURCES**

This program is subsidized by a \$1,000 scholarship provided by the Peery Institute that will be awarded to all students who are accepted to this program. The program costs \$5,400-\$5,800 without the Peery scholarship.

Regular BYU tuition scholarships, Pell Grants, and Federal Insured Student Loans may be applied to Study Abroad programs, provided the university requirements of the financial assistance are met.

Students who submit the financial aid section of the ISP application, and who have a current FAFSA form on file at the Financial Aid Office (A-41 ASB), will be considered for a Study Abroad scholarship. Academic departments and colleges may assist with scholarships and grants.

Private grants and scholarships outside of BYU may also assist (see kennedy.byu.edu/scholarships).

### TRAVEL

Students are responsible for purchasing their own airfare to and from the program. Airfare reservations must be made through BYU Travel. Students should contact a BYU Travel agent.
