# LONDON FINANCE INTERNSHIPS

FALL 2023, WINTER 2024, SPRING 2024, SUMMER 2024



A finance internship in London will provide you with unparalleled real-world experience. London is the world's most international and connected financial city, and sits at the crossroads of U.S. and European culture. Experience a semester in London and live like a young professional abroad. Students will have the opportunity to intern with the Tyrus Capital London office. Tyrus Capital manages assets for institutional investors globally, including banks, pension funds, sovereign wealth funds, family offices, foundations, and endowments. Their range of alternative investment strategies includes event and structured trades, secondary/private equity, and European real estate and global convertibles. As an intern with Tyrus Capital, students will have the unique opportunity to work side-by-side with the investment and asset management teams in the underwriting, investment, and investment management processes. In this position, students will focus primarily on investment screening, due diligence, market research, asset management, and general team support.

General responsibilities while working with Tyrus may include qualitative and quantitative analysis in relation to potential investment opportunities; supporting with due diligence workstreams on prospective investments; modelling of investments across the capital structure (whole loans to preferred equity), across asset classes, and across Europe; supporting the drafting of investment recommendation documents; supporting the drafting of investment recommendation documents; supporting the drafting wider initiatives across fundraising, asset management, finance and legal; and conducting various other tasks related to market research, internal requests, and marketing efforts with current and potential investors.

The ideal candidate for this internship will have excellent academic credentials, and will be working towards a minimum of a bachelor's degree. Junior and senior year students preferred. The ideal candidate will express interest in private equity, investment banking, financial services, real estate sectors, and have relevant experience in hard working environment. Tyrus is looking for strong modelling skills (Excel) and business acumen, the ability to multitask, and prompt delivery of assignments under deadlines. The ideal candidate will display excellent analytical, interpersonal, and written communication skills, as well as a strong work ethic with a desire to learn and succeed. The ideal candidate will also be an effective and reliable team player with a "can do" attitude. Any European language skills are a plus.

## HOUSING

Students will live in an apartment-style living in the Kensington area of London, near historic Hyde Park. Students are responsible for providing their own meals. Accommodations come with a refrigerator, and cooking facilities are available either in the apartment or on each floor.

## COURSES

Students are required to enroll in 6 credit hours during the spring or summer term programs, or 12 credit hours during the fall semester internship program. Some of these credits will be arranged as internship credit from students' majors or minors. Additional credit, including directed readings or research, will be granted by BYU academic departments. Students should consult with their department internship coordinator and ISP to learn more about these options.

Accompanying spouses are required to enroll for a minimum 3 BYU credits, but are not required to do an internship. Students may not take any other courses on this program, including BYU Online courses, without approval by the program director and ISP.

## COST

## \$6,000-6,500

Includes full-time Latter-day Saint undergraduate tuition, housing, internship placement, and international health insurance coverage. Does not include airfare, visa (approx. \$1,200), local transportation in London, personal expenses, meals. The cost for accompanying spouses is the same as for full-time students (\$6,000–6,500).

#### TRAVEL

Students are responsible for purchasing their own airfare to and from the program. Airfare reservations must be made through BYU Travel. Students should contact a BYU Travel agent: 280 HRCB | (801) 422-6293 | travel@byu.edu.

#### PREPARATION

Passports must be valid for at least six months beyond the end of the program.

Accepted students to the program must participate in required pre-departure meetings. Visas are required and should be applied for approximately four months prior to departure.

Accompanying spouses need to be credit-bearing participants on the program; they will need to apply online and participate in pre-departure meetings.

#### Students must meet all country- and program-specific COVID and health requirements for travel.

## **FUNDING SOURCES**

Regular BYU tuition scholarships, Pell Grants, and Federal Insured Student Loans may be applied to study abroad programs. Students who submit the financial aid section of the ISP application and who have a current FAFSA form on file at the Financial Aid Office (A-41 ASB) will be considered for a Study Abroad scholarship. Academic departments and colleges may assist with scholarships and grants. Private grants and scholarships outside of BYU may also assist (see kennedy.byu.edu/scholarships).

## **APPLICATION PROCESS**

Students must be adults 18 years of age or older to participate. Complete the online application at kennedy.byu.edu/isp-apply. A nonrefundable \$35 application fee is required; applicants will be interviewed once the application is complete. Students will be notified via e-mail of their acceptance into the program.
